Food For Thought ... With the current difficult economy, having needed funds for daily living requires creativity. Many people have large balances held in Traditional IRA's and think that they have no access to the funds until they reach age 59 ½. Typically, if the funds are withdrawn prior to age 59 ½, there would be a 10% penalty imposed. There are exceptions to this rule and the funds can be withdrawn penalty free under the following situations:

- You have unreimbursed medical expenses that are more than 7.5% of your adjusted gross income
- · The distributions are not more than the cost of your medical insurance
- The distributions are in the form of an annuity
- Distributions are not more than your qualified higher education expenses
- · The distribution is used to buy, build, or rebuild a first home
- · You are the beneficiary of a deceased IRA owner
- · The distribution is due to an IRS levy of the qualified plan
- The distribution is a qualified reservist distribution
- You are disabled


While these options exist to avoid the 10% penalty, it may not be in your best interest to access the funds. The withdrawal is counted as income and will be taxed at your current tax rate. Also, you may not have the opportunity to replace the retirement funds as tax deferred funds and you would lose out on the tax deferral advantage these funds have. # **Methods to Help Prevent Losses**

Now that winter is upon us, taking a proactive approach to prevent losses is vital.

Consider the following:

- 1. Have your furnace serviced. Clean or replace furnace air filters each month during heating season.
- 2. When traveling out of the area, have a neighbor/family member watch your home. Consider installing a temperature control light to indicate if temperature is 1. Check electrical cords, plugs too low so your neighbor can see if your home is potentially at risk for freezing pipes.
- Clear snow loads (have your awnings cleaned off).

Chimney cleanings are a must! Take advantage of local coupons in the penny saver ads.

- 1. After consulting your hot water tank owner's manual, drain off a dishpan full of water from the clean-out valve at the bottom of your hot water tank.
- 6. Test plumbing shut-off valves to ensure they are working and to prevent them from seizing.
- 1. Bleed air from hot water radiators.
- and outlets for all indoor and outdoor seasonal lights to ensure fire safety: if worn, or if warm to the touch, replace immediately.

While we're on the subject, here are some household maintenance tips:

- Check the hoses to your appliances and have them replaced when necessary (we've seen many un-necessary water damage and other claims that could have been prevented)
- Clean your dryer vents on a regular basis
- Check and clean your range hood filters and also clean your stove top burners on a regular
- Test smoke detectors
